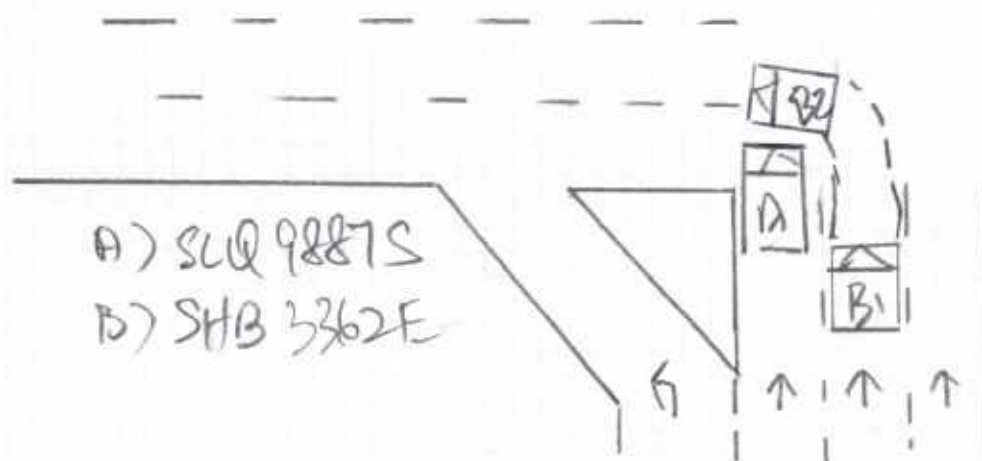

Car Rental Agreement

This Car Rental Agreement ("Agreement") is made and entered into as of 30th January 2018, between WYSA Cars, with an address of 194 Westwood Ave #08-30 S648152 ("Owner"), and Wong Ting Soen, Alvin, with an address of Blk 760 Jurong West St 74 #11-08 S640760 ("Renter"). Owner and Renter may also be referred to as "Party" in the singular and "Parties" in the plural. This Agreement is subject to the following terms and conditions:

Rental Vehicle

Owner hereby agrees to rent to Renter the following vehicle ("Vehicle"):

Model: Jazz 1.5 VTIR CVT

Year: 2015

Color: Silver

Rental Period

Owner agrees to rent Vehicle to Renter for the following period:

End Date: 28th Jan 2019

The Parties agrees that this Agreement terminates upon the End Date specified above. Notwithstanding anything to the contrary in this Agreement or any Exhibits, either Party must terminate this Agreement prior to the End Date with at least one (1) day notice. If this Agreement is terminated prior to the End Date, the Parties will work together to determine whether a refund of Rental Fees is necessary.

Rental Fees

The Renter hereby agrees to pay the Owner for use of the Vehicle as follows:

Fees: \$60/day

Fuel: Renter shall pay

Deposit: \$500. Owner shall retain this deposit to be used, in the event of loss or damage to the Vehicle during the term of this Agreement, to defray fully or partially the cost of necessary repairs or replacement. In the absence of damage or loss, said deposit shall be credited toward payment of the rental fee and any excess shall be returned to the Renter.

Existing Damage to Vehicle

The Parties acknowledge the existing damage to the Vehicle as notated below:

Insurance

The Owner provides the Renter with car insurance that covers personal injury to Renter or other persons as well as the Vehicle and the property of others.

Indemnity

Regardless of insurance coverage, Renter shall fully indemnify the Owner for any loss, damage, and legal actions, including reasonable attorneys fees that Owner suffers due to Renter's use of Vehicle during the term of this Agreement, including but not limited to, damage to the Vehicle, damage to the property of others, injury to Renter, and injury to others. This provision survives the termination of this Agreement.

Owner Warranty

The Owner represents that to the best of his knowledge and belief that the Vehicle is in sound and safe condition and free of any known faults or defects that would affect its safe operation under normal use.

Renter Warranties

The Renter agrees that Renter will not (a) use the Vehicle to carry any passengers other than Renter; (b) allow any other person to operate the Vehicle; (c) operate the Vehicle in violation of any laws or for an illegal purpose and that if Renter does, Renter is responsible for all associated, tickets, fines, and fees; (d) use the Vehicle to push or tow another vehicle; (e) use the Vehicle for any race or competition; (f) operate the vehicle in a negligent manner.

Restriction on Use

The Renter covenants to use the vehicle only for Lawful and Legitimate purposes and not to use the vehicle for any unlawful purpose activity. Vehicle is restricted to Singapore use only. Renter shall not take the said vehicle outside mainland of Singapore without the written consent of the Owner. Failure to comply with this term may entail serious consequences and The Renter shall assumed personal and full responsibility. In event of the said vehicle

being damaged, confiscated, forfeited or seized as a result thereof, The Renter shall indemnify The Owner for all the losses incurred including the full value of the said vehicle. The Renter agrees that The Owner shall not be responsible for any liability, claim, loss damage or press of any kind or nature caused directly or indirectly by the vehicle or its use. \$500 Security Deposit will be forfeited if The Renter exit Singapore with the vehicle without written consent by The Owner. The Owner reserve the rights to recover the vehicle from The Renter and all costs of recovering the vehicle will be payable by The Renter.

Other Conditions

The Renter is NOT ALLOWED to sublet or lend the hired vehicle to a third party, during or within the rental period. If the vehicle is found to be ridden by anyone other than The Renter named in the Rental Agreement, the vehicle will be seized by The Owner without any refund. If The Renter lend the vehicle to a third party without notification to The Owner, and the vehicle is involved in an accident, The Renter will bear the whole cost of the claim and repair costs of the vehicle rented and other third party claims. If the vehicle is involved in an accident, The Renter has to inform The Owner, the Police or other relevant authorities in writing of the accident and shall also notify The Owner in respect of any claim arising thereafter from the accident. No admission compromise offer payment or indemnity shall be made by The Renter without The Owner's consent in writing. The Renter shall render such information and assistance in connection with the accident as The Owner or its insurers may require. No repair is to be done without The Owner approval. If The Renter is caught repairing the vehicle at any workshop unauthorized by The Owner, compensation of S\$1,000.00 is payable to the Owner. The Renter is REQUIRED to return the vehicle key and key tag in the same condition when he / she rented from The Owner. Lost or damage of the key or key tag will be chargeable at \$100.00. Any damage to the vehicle will be charged to The Renter accordingly to the repair costs to rectify the vehicle to the same condition as it was at the start of the rental. If the vehicle was used for racing, exiting Singapore without written consent, sublet / or lend without authorization by The Owner, each causes will be payable as an "compensation" of S\$1,000.00 to The Owner by The Renter. All charges and amounts due which are not paid when due shall bear an interest of 2% per month until it is paid. This agreement shall be governed by and constructed in accordance with the laws of the Republic of Singapore and the parties agree to submit to the jurisdiction of the Courts of the Republic of Singapore. I / We have read and agree to the above-mentioned terms and conditions.
