

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving on lane 2 (second from right) along PIE towards the city at about 1800H. Traffic was heavy and slow moving. The vehicle in front of me a white Honda Shuttle SLQ4197H braked suddenly and I knocked into the back of it. The car was a PHV and had passengers in it. But because the windows were so darkly tinted, I could not see inside the car. The driver Mr. LIM CHOON CHWE said he was on his way to the airport. I asked if he was OK and if all his passengers were fine. He said they were all OK. I apologised to him, and we exchanged particulars. The roads were dry, weather was clear and visibility was good. There was damage to his boot cover and damage to my bumper, radiator grille and bonnet cover. The front left head lamp bulb was also blown.
