Circumstances Of Accident #carpark, Accident_Scenario Moving forward or reversing into parking lot & Parked, Blue Car SJT6484Z, White Car SMH7593M. Accident_Description We were both parked in the visitor car park at 93 Grange Road Grange Residence. His car was parked he was not there. I pulled out of the car park turning to the left. I took the turn too sharp and my rear left wheel clipped his front bumper and his bumper got dented. He was slightly over the yellow line of where to park within. My car's only damage is a scratch on the wheel. I notified the security guards at the condo and left them with my name and phone number. The driver Ang Jing Jie Gerald (S9230946J) contacted me 30 hours later. Initially he wanted me to pay him \$400 cash to fix the damage. Then he told me he was a GRAB driver and was renting the car and it had to be returned the next day. I then asked to speak directly with the people that own the car since Ang Jing Jie wasn't involved personally and it wasn't his car. I didn't get the contact details for his rental company until Feb 23rd. I contacted Maric Servicing on Feb 24th and spoke with Siewi (phone number 98328752). He said that his company would be submitting the claim for the damage. As I am a new driver to Singapore and new to the ways to handle submitting claims I apologize for being delayed in my accident report. I thought that it was all then handled by vehicle that wanted the car to be fixed.
