We refer to the above matter.

Third party driver reported that he was traveling along admiralty road in the left lane. As there was a parked/stationary vehicle in front of him, he then filtered slightly with his right indicator & stopped after checking for clearance from his right. When stationary, Suddenly Our Insured from the middle lane collided onto his car.

Our insured driver reported that he was travelling straight and suddenly Third Party changed into his lane and resulted in the collision.
