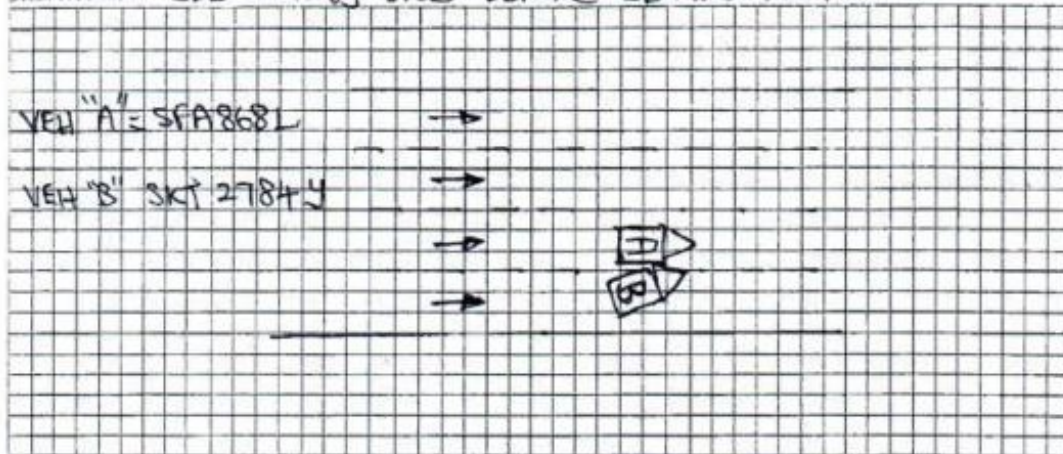

SKETCH PLAN SLE TOWARDS BKE BEFORE LENTOR EXIT.

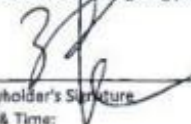


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
