I WAS TRAVELLING ALONG AMK AVE 5 SLIP RD INTO CTE TWDS CITY, SUDDENLY I RUBBER BURNING SMELL ON MY VEH, I DECIDE TO STOP AT THE CHEVRONS LINE TO CHECK ON MY VEH, BUT I NOTICED FROM MY REAR VIEW MIRROR THAT WAS A MOTORCYCLE COMING SO FAST FROM BEHIND, I TRY TO AVOID UNNECESSARY ACCIDENT, I SAW A SPACE FOR ME TO FILTERING INTO THE LANE AND THE VEH WAS SLOWING DOWN. BUT WHEN I FILTER OUT 3 QUARTER OF MY VEH, VEH B DIDN'T STOP BUT ACCELERATE AND GRAZED ONTO MY VEH RIGHT REAR DOOR. AFTER THE IMPACT, VEH B NEVER STOP AND DRAG ALL THE WAY TO THE FRONT.



B = SLT 3130R






