We refer to the above to the above matter.

We act for the owner Vetrura Leasing Pte Ltd of SJP5354T in respect of his property damage claim for the above matter. We are at post Writ stage for the above matter.

We require to do an Accident Reconstruction report to support our client's (SJP5354T) theory of the above accident against the Defendant (SLN9226R) for the above matter. The main point that our client wish to prove that the Defendant's vehicle SLN9226R (Black Mercedes) exited from Ritz Carlton Hotel without stopping at the stop line into Raffles Avenue and had collided onto our clients' vehicle SJP5354T which the said Defendant driver of SLN9226R had denied the same for the above matter.

FURTHER STATEMENT GATHERED FROM OUR CLIENTS' DRIVER MR EDWARD NG YONG YEW OF SJP5354T

Our clients' driver Mr Edward Ng Yong Yew of SJP5354T mentioned that he was driving along 1st lane (right most lane) along Raffles Avenue when he was nearing / almost to the Exit point of Ritz Carlton's driveway towards Raffles Avenue, he saw the Defendant's vehicle SLN9226R (Black Mercedes) driving fast along the said driveway of Ritz Carton to Exit into Raffles Avenue. Our client's driver of SJP5354T anticipated that the Defendant's vehicle SLN9226R (Black Mercedes) might not stop at the said exit and thereafter, our clients' driver of SJP5354T veered slightly to the 2nd lane along Raffles Avenue when the said Defendant's Black Mercedes of SLN9226R's front left portion collided onto the right front driver door of SJP5354T (1st impact - moderate to serious damage to the right front door). Upon 1st impact, both vehicles were still in motion and our client's driver of SJP5354T was still attempting to brake to stop his vehicle and along which his vehicle SJP5354T's right side rear door was damage (2nd continuous impact - right rear door area damaged - slight to moderate impact). The eventual landing position as shown in the photographs taken at the scene of the accident.
