Circumstances of Accident

I WAS DRIVING ON THE LEFT MOST LANE ALONG BENCOOLEN STREET. I SAW A COMFORT TAXI STOP AHEAD WHERE HALF OF THE TAXI BODY WAS INSIDE MINOR ROAD AND HALF OF IT'S BODY IN MY LANE. AS SUCH I KEEP RIGHT BUT STILL WITHIN MY LANE AND CONTINUED TO DRIVE FORWARD. SUDDENLY I HEARD A CRASHING SOUND AND IMMEDIATELY STOPPED MY BUS AHEAD TO ASSESS MY BUS. 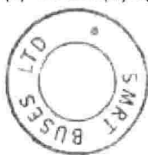

 - (ii) for complying with requirements under any regulations, laws or court orders.



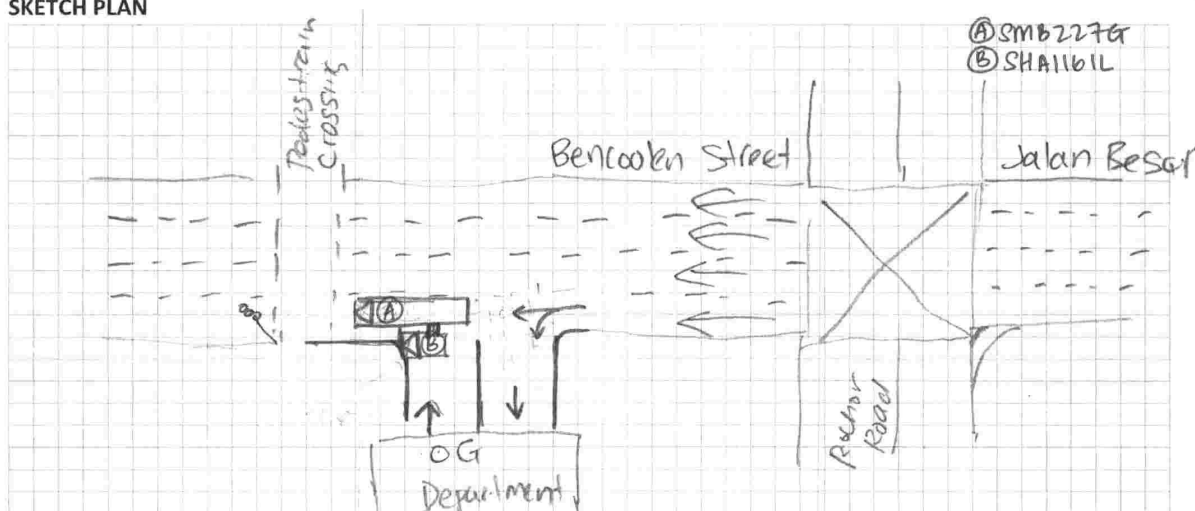
