Brief Details.

On the 21st October 2018 between 5.50pm to 6.05pm at level B1 of Tiong Bahru Plaza carpark, my motorcycle FBK7667Z was knocked down to the ground, lifted upright again and the culprit left the scene without any note or details about the incident. The incident happened just right in front of the entrance where KFC was the first shop to be seen once you enter from B1 carpark. I was doing Grabfood at that time to take my order at Paik's Bibim restaurant at the 2nd floor of Tiong Bahru Plaza.

At that point of time around 5.50pm, I rode my motorcycle to Tiong Bahru Plaza level B1 carpark and park just behind a car plate number SKQ4115G which was parked in a parallel parking space. As I left my motorcycle, the owner of SKQ4115G was seen with a trolley of bags and was seen wanting to leave. So I did not bother and proceed to enter the mall.

When I came back at around 6.02pm, the first thing I realised was that my motorcycle was shifted, helmet placed at my right side mirror and my left handguard was damaged. Also there was another car that took the parking spot of the previous car. The plate number is SJF6567F.

I quickly inspected my bike and found damages on the left side of my motorcycle which are left handguard, left mirror scratches, left crashbar scratches and left side of my rear box dented. There were also rattling and squeaking sound from my front part of my motorcycle and also at the rear box when I moved off from there as there was nothing I can do at that point of time. There were also markings on the floor that indicated my bike has been knocked down. I asked the owner of the vehicle SJF6567F who was just about to alight from the vehicle regarding my motorcycle and he said he did not know as he just arrived.

I believed one of this two cars knocked down my motorcycle and did not even have the decency to leave me a note or owned up. I managed to get this 2 cars plate numbers is because I have camera for my motorcycle which was switched off once I switched off the motorcycle.

There are a few CCTV cameras around that area which may be of help for your investigation. I would like to know who the culprit is so that I may request for a settlement or insurance claim for my bike damages. I will upload the picture of my video as my motorcycle video files are a mess and does not have full video for any journey I take but I managed to find the 2 car plate numbers by reviewing everything.
