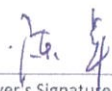

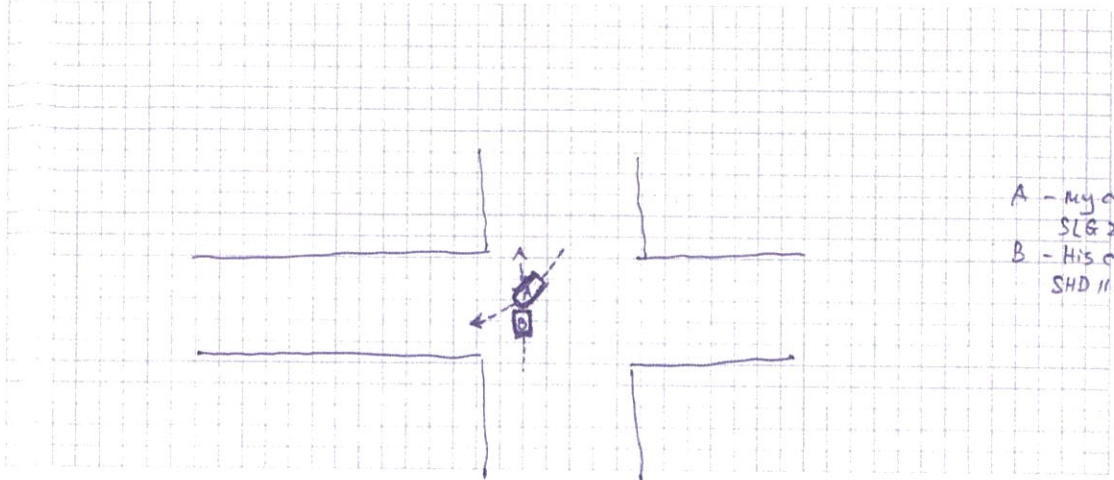

LOCATION: <u>At the junction of Bukit Timah Road and Kheam Hock Road</u>	
I was on the Kheam Hock Road, turning right to the Bukit Timah Road. The traffic light in front of me is green, I'm very carefully to be aware if there is any car going or attempt to move. I didn't find any car attempt to move at that moment, so I begin to slowly and carefully turning to Bukit Timah Road. Then suddenly, there is a taxi (SHD1169A) driving directly into me. I was half on the junction at that moment, so I stop immediately. The taxi also see me and begin to stop. (The taxi was driving directly at Kheam Hock Road then. He is crossing the Bukit Timah Road.) However, the taxi didn't fully stop before bump into me. So the front left corner of my car is bumped by the middle front end of the taxi.
