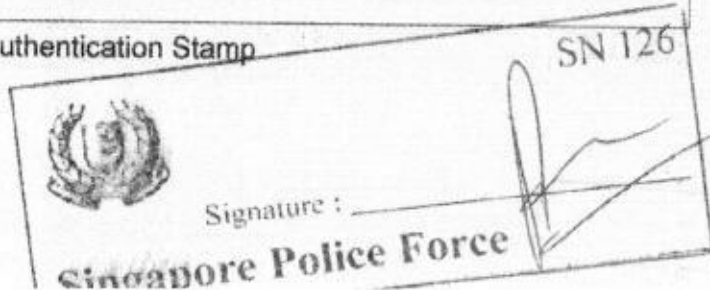

Before I was about to move off, V2 had collided onto the rear of V1 from the front. There is a slight scratch at the left rear of V1. There was no passenger in V1. There is one passenger in V2. No one was injured. I then got down from V1 and wanted to exchange particulars with the driver of V2 however he refused to pass me his particulars. The driver of V2 said he was rushing as he was having a passenger in his vehicle.
