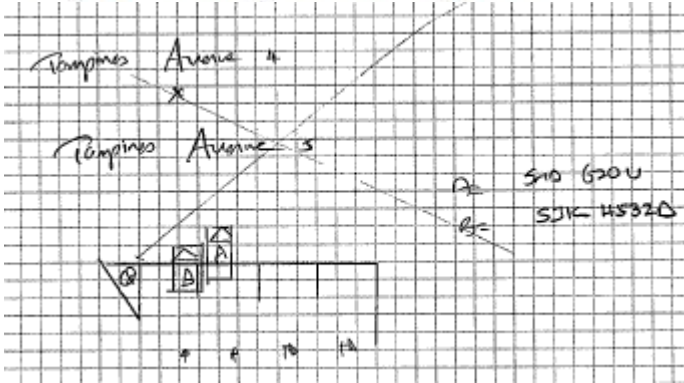
Dear Vic
