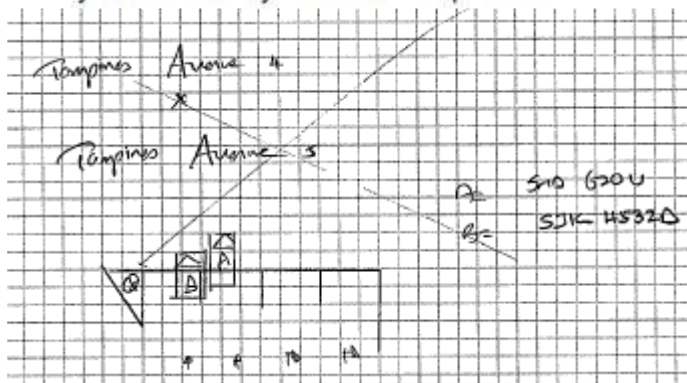
Dear Vic
