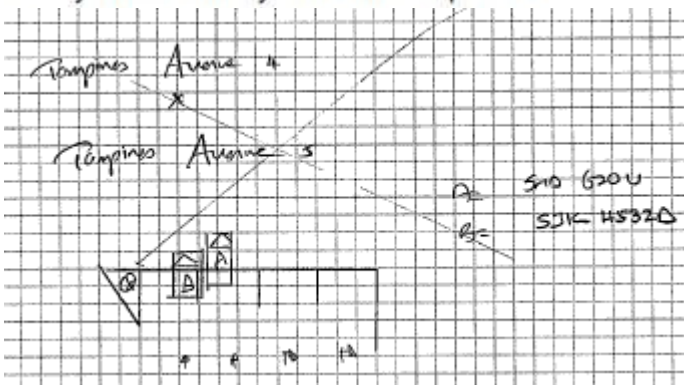
Dear Vic
