SKETCH PLAN

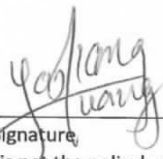
IMPORTANT NOTICE

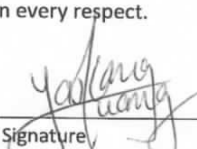
SKETCH PLAN**DESCRIBE CIRCUMSTANCES OF THE ACCIDENT**
