**Brief Details.**

On the 09/03/2019 at about 1045hrs, I was riding FBF7755D and my wife Tan Ai Meng HP:96663063 along Serangoon Ave 2 and was on the filter left lane into Upper Serangoon Road towards Kovan direction. After the zebra crossing, I was checking on oncoming vehicles along Upper serangoon Road and suddenly there was a collision came from the rear of my motorcycle and it fell onto our left. We then discovered that our vehicle was hit by a vehicle SGC405S and the driver came to assist us who is one Mr Koh Kim Huat HP: 96903630. My wife and I were both conveyed to Tan Tock Seng Hospital as I suffered some superficial abrasion on my left elbow knee cap and ankle while my wife left foot was swollen. After seeking medical attention at Tan Tock Seng Hospital, my wife was given 5 days of MC as she is not able to walk properly and now using a walking aid. I was informed by the traffic police to lodge a report about the said accident.


