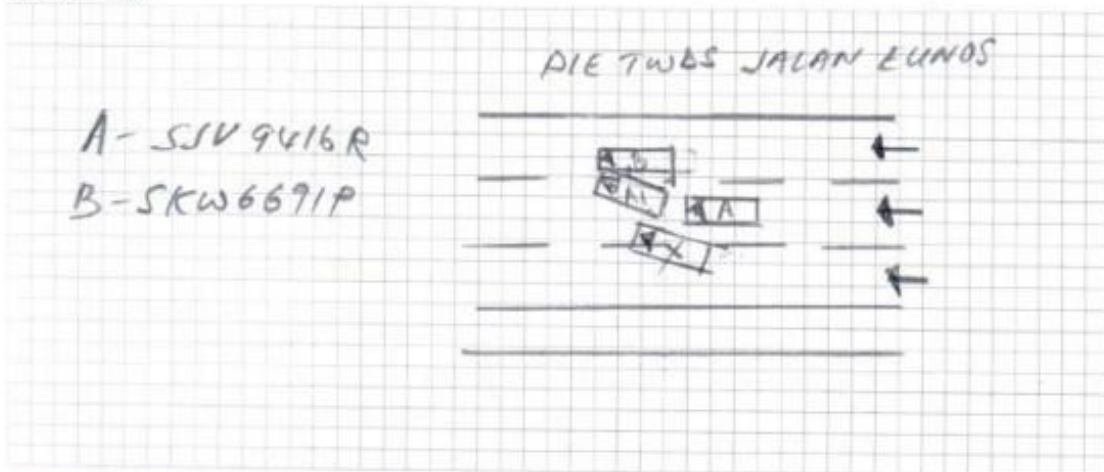

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At about 11:40 am morning on 23/03/19, I was driving up PIE from Tumpines ave 5. ~~Upon~~ After moving up the slip road, and entering the main highway roadway, a vehicle in front had made a rather sudden right lane change when my vehicle was very close behind. I ~~soon~~ change lane to lane 2 and honned the front vehicle to alert him of my vehicle that is very close behind him. Soon after, he decide to make another lane change knowing that my vehicle is closely after him. To avoid collision of my front with his bumper and prevent vehicles behind from hitting my rear (as the vehicle behind were close about one or two vehicle space away), I did not jam brake my vehicle but only slowed down a little and swerved to the right and this lead to a scratch of my side mirror with another vehicle's side mirror.
