Circumstances of Accident

ON 24/03/2019 AT ABOUT 1630 HRS. WHILE I WAS TRAVELLING ALONG TUAS CAUSEWAY TOWARDS TUAS CHECKPOINT. VEHICLE B CUT INTO MY LANE. THERE WAS TRAFFIC HEAVY . TO AVOID OTHER VEHICLE CUT INTO MY LANE , MY VEHICLE IS MOVE FORWARD AND NEAR TO REAR OF VEHICLE B. VEHICLE B SUDDENLY ROLL BACK AND HIT ONTO MY VEHICLE FRT PORTION . AFTER THE ACCIDENT, WE DECIDED MEET AT THE CHECKPOINT, BUT I WAIT OVER THERE COULDN'T FIND DRIVER OF VEHICLE B . THE DAMAGE IS VERY INSIGNIFICANT . THEREFORE I DECIDED NOT TO CLAIM AGAINST HIM AND DID NOT MAKE ANY REPORT UNTIL I RECEIVED THE LETTER FROM INSURANCE COMPANY. MY VEHICLE IS ALREADY SCRAP .

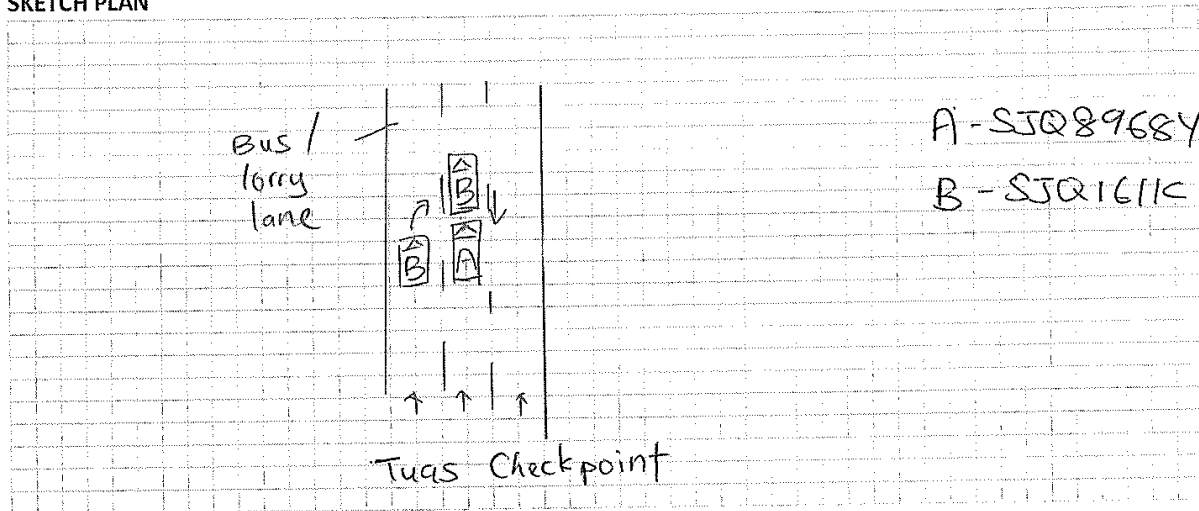
