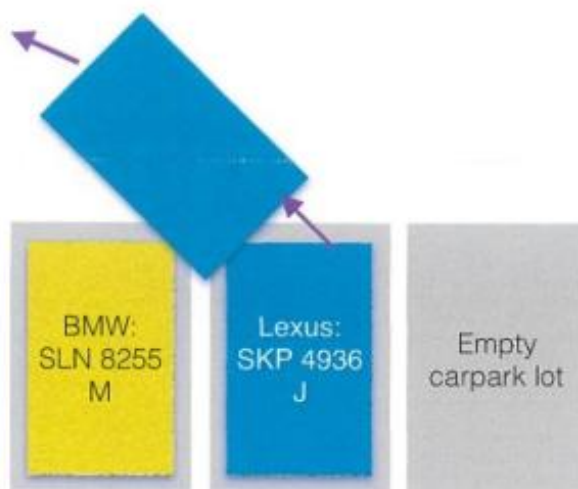

Details	<p>I drove my husband's car (SKP 4936 J) to Hougang 1 on 23 March 2019. When I was turning left to move out of the carpark lot, the left rear of my car came into contact with the front right side of a white BMW (SLN 8255 M) which was parked on the left of my vehicle.</p> <p>The BMW sustained some damages. Based on observation, the front right headlight of the BMW was cracked, and some parts of the front right bumper fell off. There were scratches on the front right side of the BMW as well. My vehicle was also scratched and dented at some spots on the left rear area.</p> <p>As Hougang 1 customer service did not provide paging services, I left a note to the BMW owner to say that I will pay for the damages of his car, as he was not in his vehicle then. The owner of the BMW, Jimmy, called me back at about 2130hrs on the same day.</p> <p>As the accident happened on Saturday, I can only make a report today (25 Mar 2019, Mon).</p>
