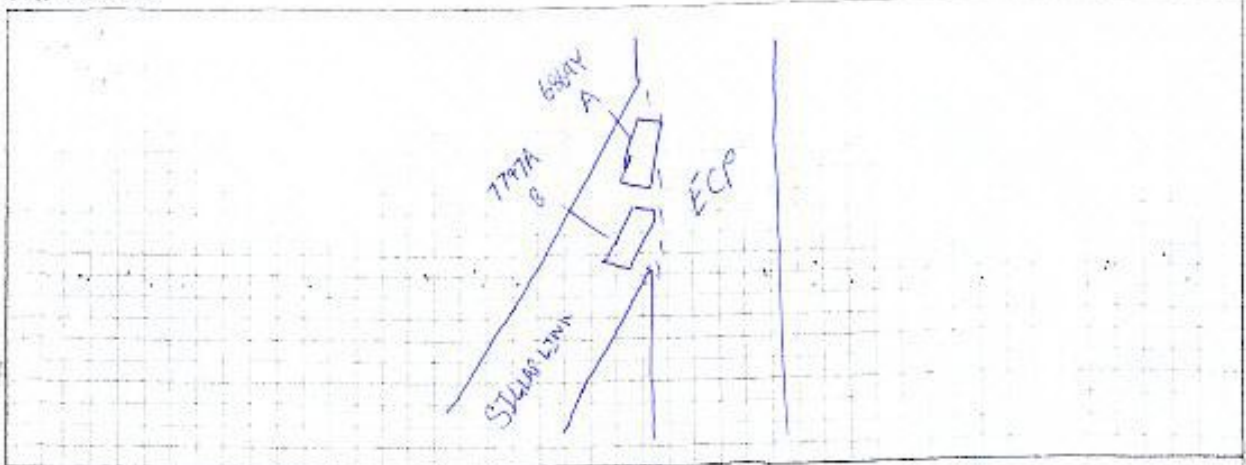

- The accident occurred on the 23<sup>rd</sup> of March 2019 at a time roughly between 19:20-19:25.
- I was the first car filtering into the ECP highway via the Siglap link.
- As it was the peak hour, traffic was relatively heavy on ECP towards Changi Airport and I had no space to filter into the highway.
- I slowed my car down and eventually stopped with "RIGHT" signal turned on at the end of accelerating lane (one way) to wait for the opportune time to filter and join the ECP. While I was looking out my right for oncoming vehicles, I was also looking out at the rear mirror. Suddenly to my surprise, I noticed a white Mitsubishi (SJQ7747A) driven by Ms. Wong Yu Bing, (Yvonne) approaching at a high speed behind my car, attempting to filter into the highway via my right instead of queuing behind me. The next thing I knew was the front left edge of her car hit the back right bumper of my car.
- Due to heavy traffic and realizing that it was dangerous to get out of the car, I led her out of the highway onto Bedok South Ave 1 and parked along Nallur Road to settle the issue.
- Damage found on my car was a large dent due to the great impact, and there were scratches at the back right of my car too.
- Damage found on her car was a small dent with her bumper out on the front left of her car.
- No physical injuries were sustained as a result of this accident.

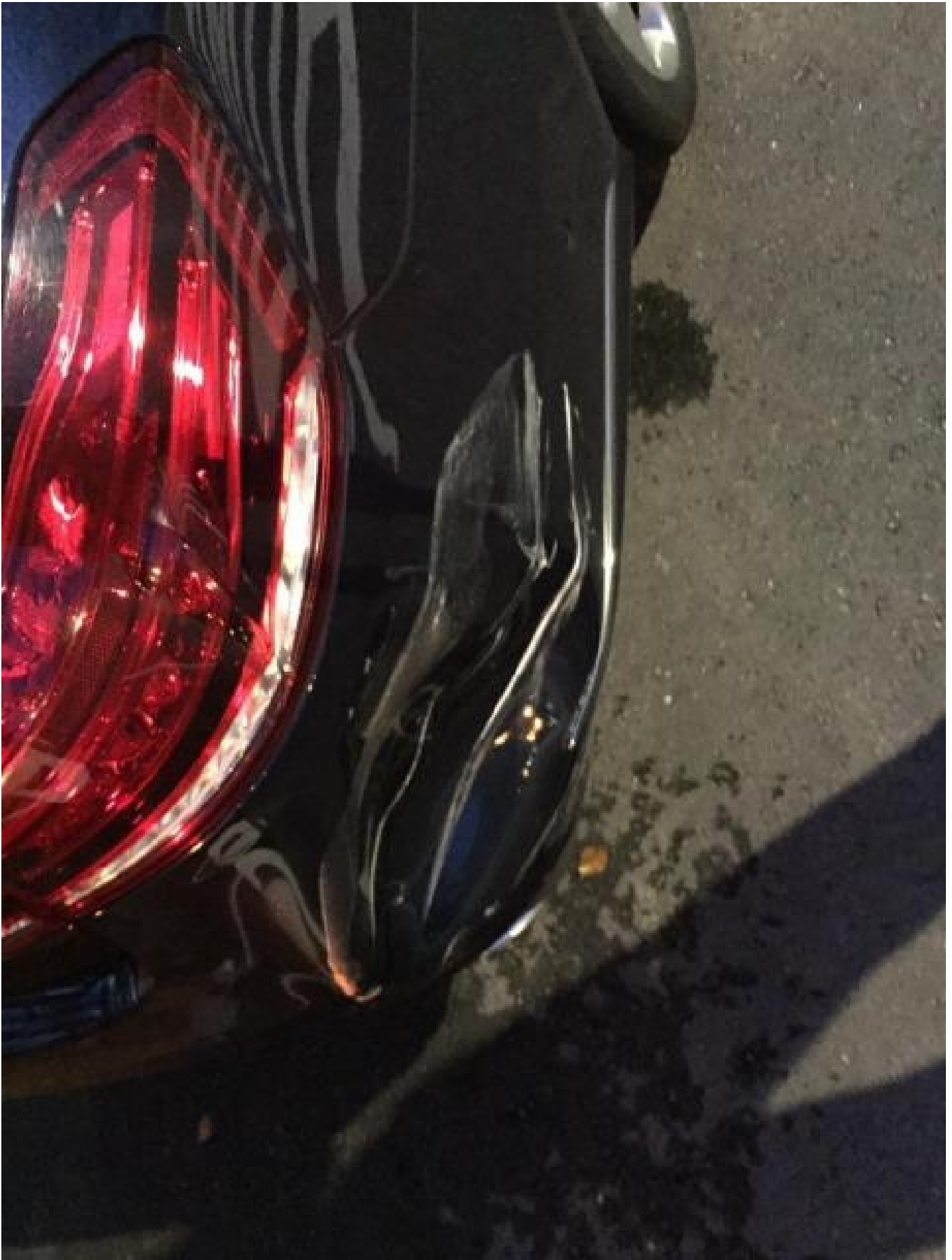
