

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

WAS DRIVING ALONG BOON LAY WAY TOWARDS JURONG WEST AFTER EXITING WESTGATE MALL. ON 3-LANE ROADWAY I WAS NAVIGATING ON THE CENTRE LANE PROCEEDING TO LEFT LANE. WHEN THE TAXI VEHICLE SHB 8420 M JAMMED BRAKE AS HE WANTED TO FILTER TO THE RIGHT LANE I JAMMED THE BRAKE BUT WAS UNABLE TO STOP IN TIME & HAD TO SWERVE LEFT FASTER THAN PLANNED BUT HIT THE LEFT REAR BUMPER AND HIT HIS REAR BRAKE LIGHT. AS THE ROAD WAS WET AT THE TIME, THE HIT WAS RATHER HARD.
