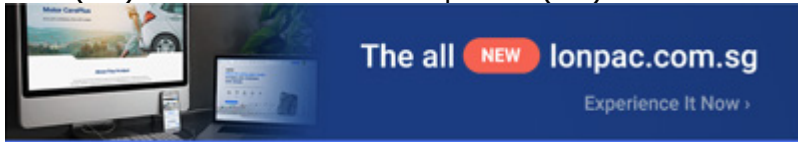
We are unable to comment on liability as our insured has yet to lodge the report.
