ON 25/03/2019 AT ABOUT 1340HRS, I WAS TRAVELLING STRAIGHT ALONG THE FIRST LANE OF ORCHARD TURN TURNING RIGHT TOWARDS TAKASHIMAYA TAXI STAND TO DROP OFF MY PASSENGER. I WAITED FOR ONCOMING TRAFFIC TO PAST AND PROCEED TO TURN RIGHT, SUDDENLY VEHICLE B(GBF4104C) CAME FROM THE OPPOSITE SIDE AND I STOPPED MY TAXI. VEHICLE B SOUNDED HIS HORN AND DID NOT ATTEMPT TO SLOW DOWN, AND HIS FRONT RIGHT PORTION COLLIDED ONTO MY FRONT LEFT PORTION.

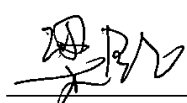
