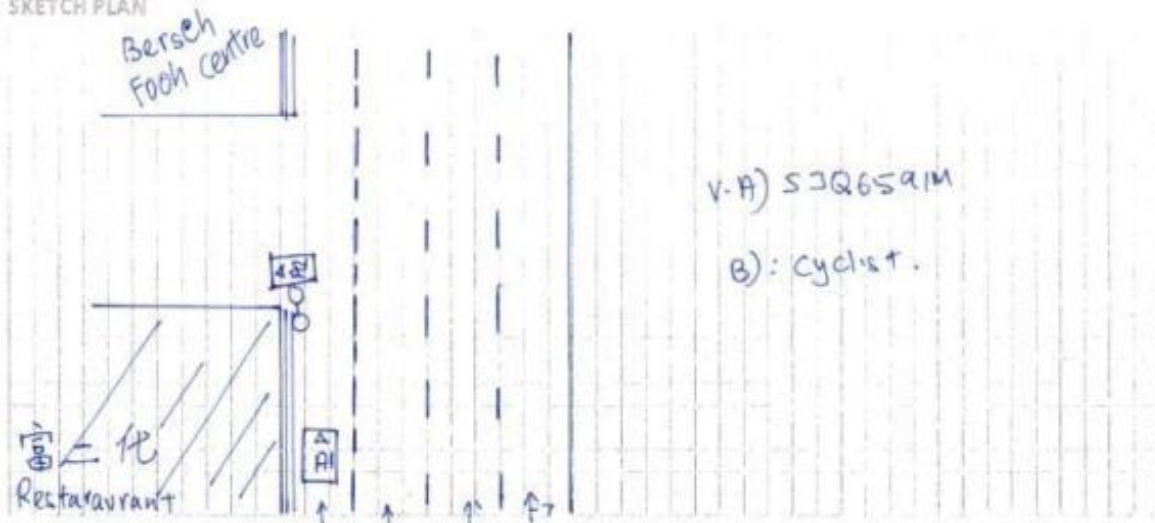

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I have received instruction from my rental company to file this report. They have received a traffic police letter from Traffic police stating that I was involved in an accident happened along Jalan Besar towards Jalan Bersih. A cyclist as I recalled was cycling along the main road with a group. I was travelling at a very slow speed and was about to Jalan Bersih road. I've checked my blind spot and ensure it's clear, suddenly the cyclist came at a very fast collided onto my vehicle front left portion. He fell off from the bike. I immediately got down and check on him. He said he was fine. there was no injuries, I asked him the 2nd time if he was okay, he repeat that he was totally fine, and even ask if my car was okay, I told him that my car is fine, no worries about, and I asked him the third time if he was alright. Again, he ensured that both of us are okay hence he did not request my particular. I then left the scene as there was no injuries nor serious damage. Until today, 29th March 2019, my rental company told me that the cyclist has filed a report against me, hence I came forward to file this report as instructed. I recalled there was no visible injuries on the cyclist and he was wearing a sport attire with helmet on.


