

Brief details.

I was riding my motorcycle (FBM 4972B) along woodlands avenue 12 towards the SLE entrance. I saw a taxi (SHC 3124X) stopped on a forward+right turn lane with a bus (PC 7674D) stopped on its left. There was a gap between the two vehicles. I decided to pass the taxi on its left, in the gap between the taxi and the bus, as i was going forward but the taxi was turning right.
