

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling straight along Dairy Farm Rd. Suddenly at the T-junction between Petir Rd and Dairy Farm Rd, car 1 came out from Petir Rd, turned left without stopping at the Give Way line and looked for the on-going traffic and cut into my way/lane with high speed and her car collided with mine as illustrated in the figure above. The driver of car 1 admitted that she was distracted by the car 2 which just made a U-turn at the junction but got stuck at the junction and hence partially blocked the view of driver car 1. The accident happened on Sunday, 31 March 2019, at 8:40 am.
