We refer to the above matter.

Third Party reported that our insured driver was changing lane and collided onto the right front portion of third party's taxi.

Our insured driver reported that he attempted to cut in the first lane and swerved back on his own lane while he heard a horn from third party.

Based on the video provided by third party, it shows that our insured front left has already entered into left lane and tried to swerve back to right. The point of impact to taxi's right front is consistent with its scenario. However, insured driver insisted that there was no contact with third party's taxi as there is no damages on his vehicle and said that is old marks for the taxi.
