





CAR RENTAL AGREEMENT

- ONLY PERSON ABOVE 23 YEARS OLD AND NOT OVER 65 YEARS OLD WITH MORE THAN 2 YEARS DRIVING EXPERIENCE, AUTHORISED, LICENSED AND SIGNING THIS AGREEMENT MAY DRIVE THE VEHICLE
- Vehicle is strictly for use in Singapore only and may not be driven out of Singapore without prior written consent of EasyDrive Car.
- 3. Use for vehicle for illegal purposes (e.g. in connection with theft, drug pedalling or trafficking, smuggling) is strictly prohibited.

 interest in it shall pass on to the Hirer.
- The hiring shall commerce on the dates and at the time specified and shall continue for the period and end on the date and at the tie stated unless extended or as expressly requested by the Hirer.
- The Hirer shall pay in full the hire charge specified herein before the commencement of hiring. No part of such hire charge shall be in any circumstances be refunded.
- 4. If the Hirer shall fail to return the said vehicle at the expiration of the period of hire, then without prejudice to the other rights of the Owner, the Hirer, shall pay to the Owner for every hour elapsing between the time of such expiration and the said vehicle is returned to the Owner, such further other change in accordance with the owner's current rate of hire charges or at such other rates as the Owner may in its absolute discretion thinks fit. All charges and amounts due which are not paid when due shall bear an interest of 1.5% per month until they are paid.
- 5. The said vehicle may only be driven by the Hirer or the persons who have expressly designed and authorised therein (herein after called "the authorised driver"). The Hirer and the authorised must be in possession of a valid driving license and shall at all time drive the said vehicle in a careful and skilful manner, observing the traffic regulations and laws and in the event of any breach thereof, the Hirer shall pay all fines, cost of repairs and penalties which may be incurred and shall also answer all police and Traffic Court Summonses, Notices and inquiries in connections therewith. Particular attention is to be accorded to the following:
 - The Hirer shall not carry load or passengers in excess of the Motor Vehicle's licensed carrying capacity (i.e. one driver and four passenger)
 - b. The Hirer shall not drive the aid vehicle whilst under the influence of intoxicating liquor or drugs
 - c. - 7. The Owner shall not under any circumstances be liable to make payment to the hirer in respect or to indemnity the Hirer against any loss, injury or damage sustained by the Hirer or by any third party as a result of the use of the said vehicle the hire shall be deemed to satisfy himself that is in all respects roadworthy and in a proper and safe condition.
- 8. - The said vehicle shall be covered under a Vehicle Insurance Policy which contains an excess Clause as Stipulated/Stated inside teh current Owner's Car Rental Folder.
- 10. On prior to the expiration of the period of hire, the Hirer shall return the said vehicle together with all tyres, tools, accessories and equipment to the Owner's designated stations in as good order and condition as the said vehicle was when collected by the Hirer from the Owner.
- No relaxation, forbearance or indulgence by the owner in enforcing any of the terms and conditions of this agreement shall prejudice
 or affect the rights and powers of the Owner hereunder nor shall any waiver or any breach operate as a waiver of any subsequent or
 continuing breach.
- 12. The Hirer is responsible for obtaining the required cash with sufficient balance prior entry into any roads within the ERP system
- In the breach of the terms and conditions of the agreement, the Owner reserves the right to presume possession of the hired vehicle
 at any time from the Hirer in the Owner's interest without prejudice.
- 14. The Owner shall not be liable to the Hirer or any person for any loss or damages whatsoever and howsoever caused or occasioned by reason of the owner resuming possession of the vehicle nor shall the Owner be liable to any person for monies, good, articles or things not belonging to the Owner which are in or alleged to be in the vehicle at the time the Owner resumes possession of the vehicle.
- 15. The hirer shall not take the vehicle outside mainland Singapore, Malaysia or any other territory outside Singapore without the written consent of the Owner. Failure to comply with this term may entail serious consequences and the Hirer shall assume person and the full responsibility and in the event of the said vehicle being damaged, seized, confiscated or forfeited a a result thereof, the Hirer shall indemnify the Owner for all Josses incurred including the value of the said vehicle.
- 16. 
