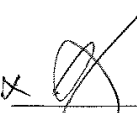
SKETCH PLAN

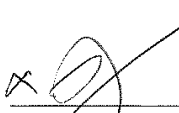

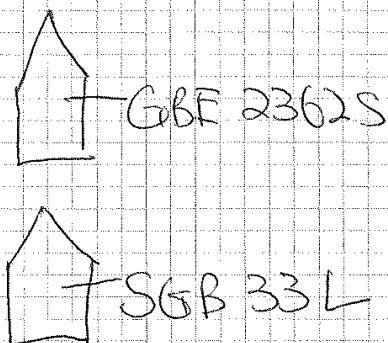
