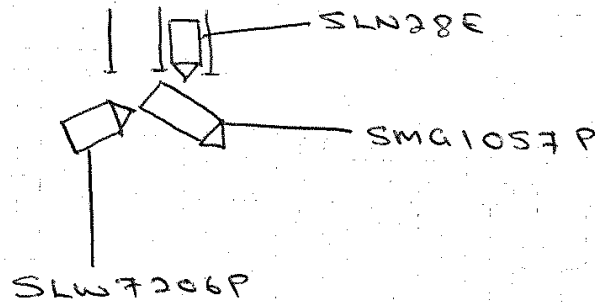

Brief Details.
