


I understand, acknowledge, agree and consent that:

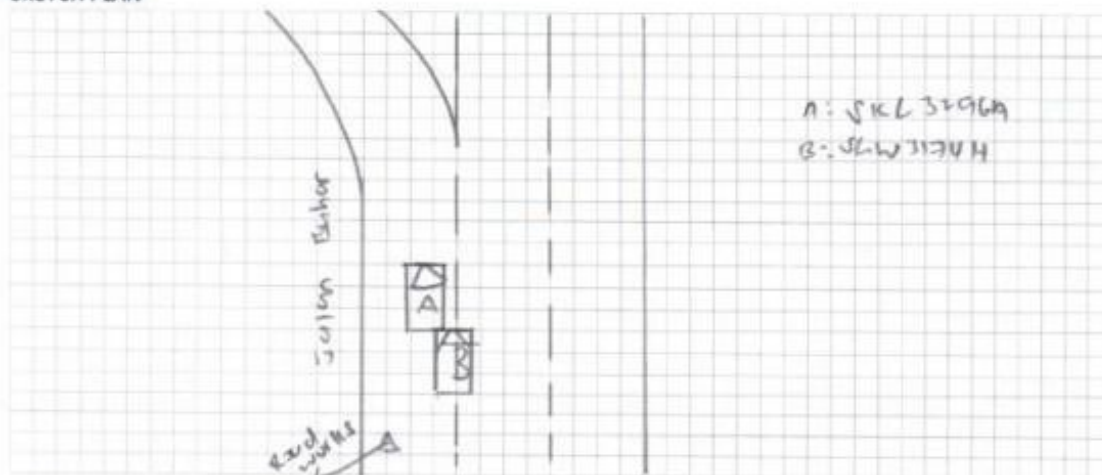


### Accident Sketch Plan
