Accident Sketch Plan



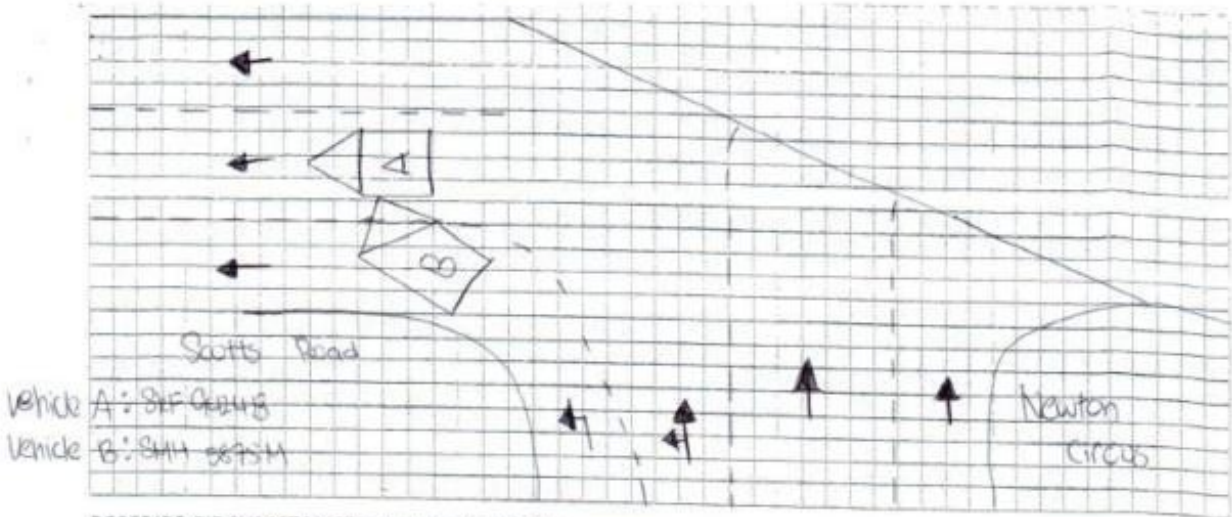
