## ROAD TRAFFIC ACCIDENT INVOLVING VEHICLE NOS. SHC 2324S AND SG 1745R ON 11/03/2019

We refer to the above matter.

Our principal have reviewed the circumstances of the incident and given some points of view as below:-

- North Woodlands Drive is a One Way Road consists of 3 lanes. The right lane is designated for Bus travelling, whereas left 2 Lanes merged after the junction with North Woodlands Link. The left lane is for Civilian Car, The right lane confines to bus travelling.
- From the video footage of Our Insured, the accident took place while both negotiate a left bend in their respective lane. It was your driver after negotiating left bend its front portion encroached into left lane when our Insured was travelling Thus causing the accident.
- Your BUS is not supposed to travel left merged lane. It must travel on right lane, these two lane separate by single yellow line in the centre.
- It is not necessary for our Taxi to squeeze in with the Bus when Taxi has its own lane to travel.
- It is obvious that your bus intended to turn left into Woodlands Square encroached into Taxi's left Lane and causing the accident.

As such, we are of the opinion that your driver is liable by encroached into our Insured path and causing an accident.

In view of this, we regret to inform you that we are unable to look into your claim.

We will now close the matter in our end.
