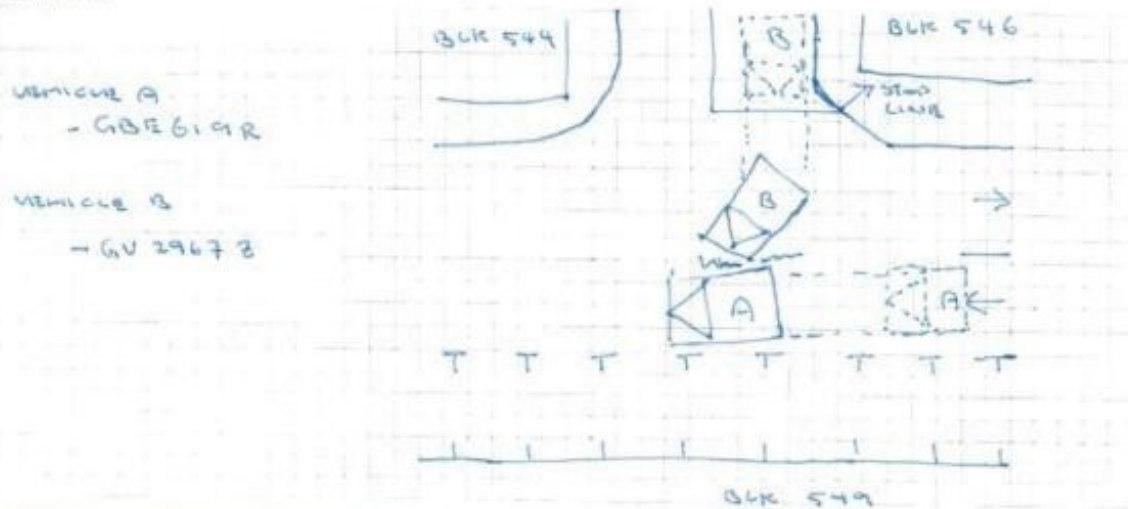

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

OPAN CAR PARK (UN336).

WHILE DRIVING PASS BLK 546 ON MY RIGHT, SUDDENLY A VEHICLE
PUSH OUT FROM THE ROAD ON MY RIGHT, IGNORING OF THE
STOP LINE. I TRIED TO SWERVE MY VEHICLE TO PREVENT THE
COLLISION BUT NEVERTHELESS THE VEHICLE STILL, HIT ONTO THE
