1. I/We, the owner of vehicle no. SLA4127U hereby instruct and authorise you to commence repairs to the said vehicle. Pending the outcome of my/our claim against the third party, I/we forthwith pay you the sum of \$2666.93 being refundable deposit of the repair costs to my/our said vehicle.
2.
