It was reported that Insured vehicle was involved in a 3 vehicle chain collision and was the last car and rear-ended the TP vehicle.

We had spoken to the Insured and was informed of the TP claim and NCD issues. A letter was sent out to the Insured. No feedback received till date.

As such, in view of MCF and BOLA 28, liability may not be to our Insured's favour and we have to settle the claim from the TP vehicle and the damages sustained to TP vehicle were consistent to the nature of the accident.

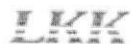
