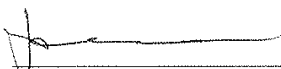

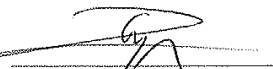

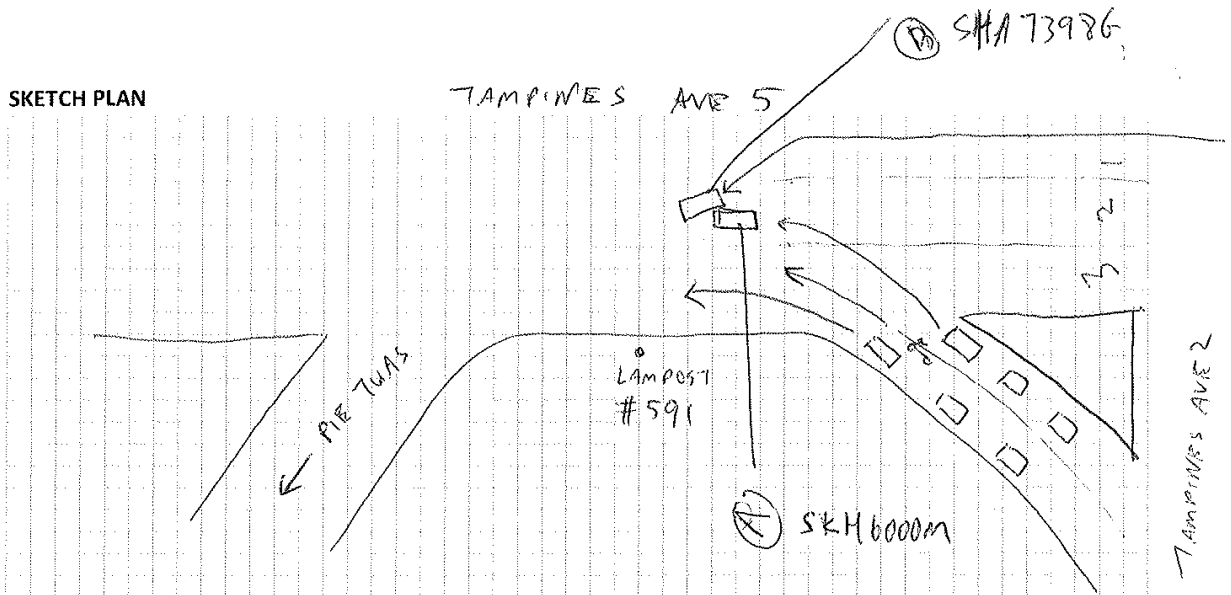

- Safe to go, Proceed to Filter out
- ~~while~~ after entering Lane 2, SHA73986 made an abrupt switch into Lane 2.
- No signals was made by SHA73986 all these while.
- I was unable to swerve to avoid nor stop as Lane 3 has vehicles, motorbike and my rear has vehicles too.
- SHA73986 slammed right into my car.
- My SKH6000M: front right bumper, right fender and front right rim was damaged.
- SHA 73986: Left rear passenger door and left side skirt was damaged.

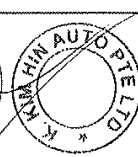
