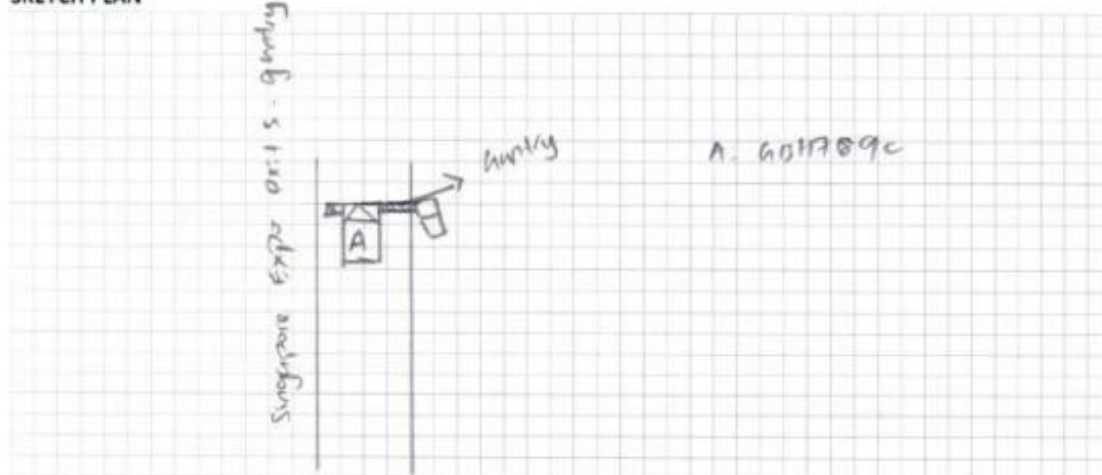


### Accident Sketch Plan
