## LETTER OF AUTHORITY AND INDEMNITY

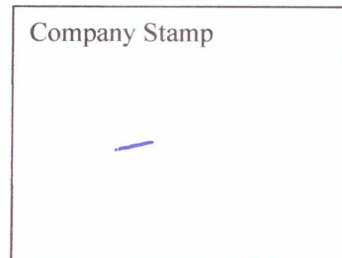
