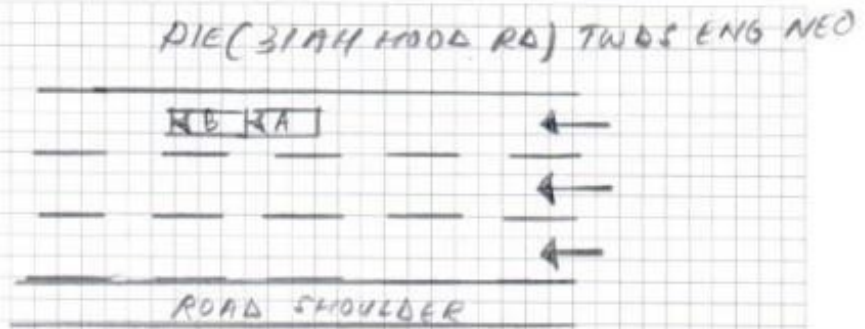

Hi Suying,

This email is to explain why I did not report this incident (see MSIG attachment) at IDAC.

On 31 Mar 2019, there was a heavy traffic jam along the PIE in the direction of Tuas (near the Ah Hood Road exit). My car (I was the driver) was part of the jam behind the vehicle SME3559E. I bumped into the back of SME3559E. When the driver of SME3559E and I went to do investigations, we found a slight dent on the rear door of SME3559E. I assumed that the driver of SME3559E was going to report his damage to IDAC. My car's front bumper had some white residue that could easily be removed by myself.

Based on what transpired above, I did not report this to IDAC. However, having spoken to you, and after receiving this MSIG letter attached, I will make a report to IDAC tomorrow morning.

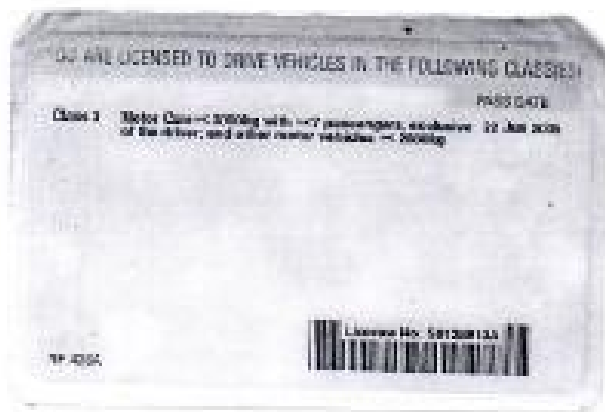
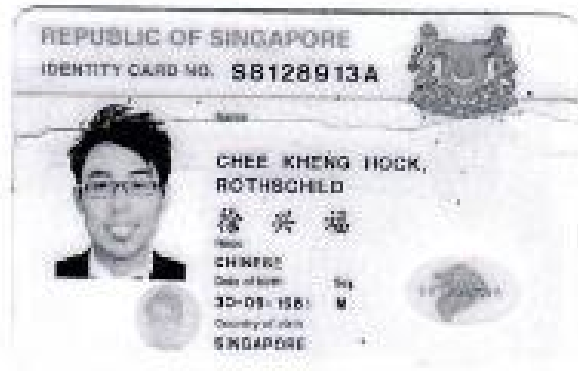
