#### Brief Details.

On the mentioned date, time and place I accidentally knocked down a pedestrian at the crossing along UPPER THOMSON ROAD near to SPC petrol klosk. i-was making a right turn from JALAN LEBAN into UPPER THOMSON ROAD towards SEMBAWANG ROAD direction. I recall seeing the traffic light was green in my favour. I do not recall what was colour of the pedestrian light, whether it was in the favor of the said pedestrian or not. She was conscious and alert when the ambulance subsequently arrived and conveyed her to a hospital. I do not known which hospital she was conveyed to. I was told by the attending TRAFFIC POLICE officer at the scene that TP investigator "JEFF" Tel: 65476311 will be contacting me with regards to this accident. The damage to my car was a dent in the front centre grille. I do not recall seeing any visible injuries on the said pedestrian. I recall seeing the pedestrian to be in her 30s, quite fair complexion but I do not know what is her race. I think she could be a Malay and I believed she is a SPC staff because there was another lady at scene who told me so. I did not verify this information with anyone from the nearby SPC petrol klosk.

I recall there was a independent eye witness who was engaged by the attending TRAFFIC POLICE officer at the scene. I do not know his contact details nor did I spoke to him. I also wish to state that my driving recorder memory card was given to the attending TRAFFIC POLICE officer.
