
### **ACCIDENT INVOLVING SGG 295X AND SFW 8999Z ON 06/04/2019**

Please find enclosed the video footage for your kind attention.

Your client report is inconsistent with the video. Your insured is not speaking the truth. Secondly this is a residential area with cars parking on the road.

Both driver are neighbours knowing that care had to be given when turning as car coming out/exiting has to change lane as there are parked cars all the time.

When your insured turned left abruptly without stopping or slowing down (at the point of turning). He did not check for oncoming traffic on both lanes (due to parked vehicles outside their houses before make the turn).

It is common understanding for all drivers to drive with care and to give way (due to parked vehicles) in such residential area. Our driver has to encroach into the other lane as there was parked vehicle. Our client's did drive back into his lane and stopped when your insured hit onto our client's vehicle.
