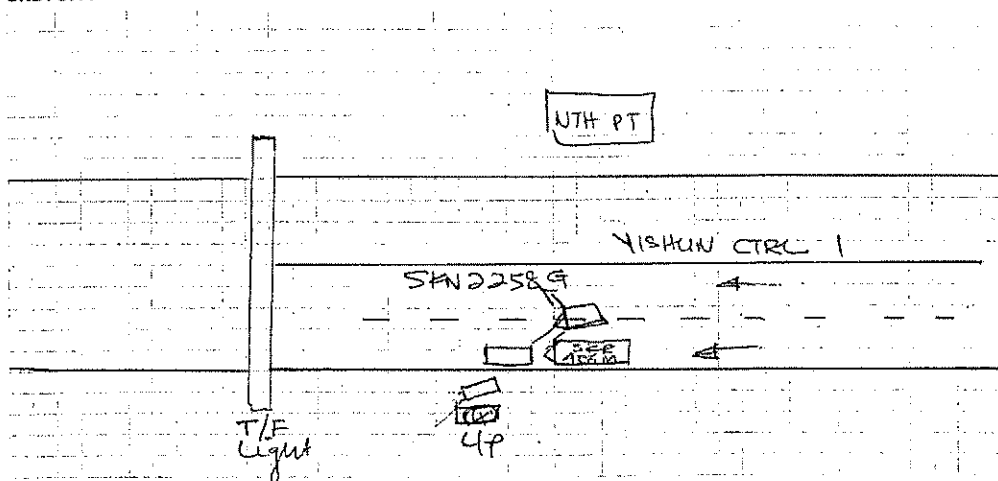

Incident : I, Manokaran s/o Mookkayyah (S1406380C) was driving my vehicle (BMW X4 SKR406M) in Yishun heading for lunch at Northpoint City with my family. When I turned onto Yishun Central 1, the traffic light between the bus interchange and Northpoint City turned red. I pulled my car to the extreme left lane as my wife was intending to alight there because she was having a terrible stomach ache and needed to go to the toilet asap. I had my double signal switched on. It was evident that my vehicle was stationary. Upon alighting, the traffic light turned green when I was about to move off a black Nissan Sylphy SKN 2258G switched lane cutting into my lane. Ignoring her blindspot, she came into my lane abruptly; hitting onto my vehicle near the driver's side headlight and damaging it badly. The driver of the Nissan Sylphy SKN 2258G is Phua Lon Shi (S7401397Z).
