We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a third party claim(s) from CHENG HOE MOTOR PL acting on behalf of the owner of SLE5808K against your motor insurance policy.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by the owner of SLE 5808K. Kindly refer to the attached video from SLE 5808K for your easy reference. We observe that third party was driving within his own lane, your vehicle changed lane and collided onto third party. As such, we are of the view that liability is not in your favour. We shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.

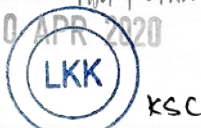
