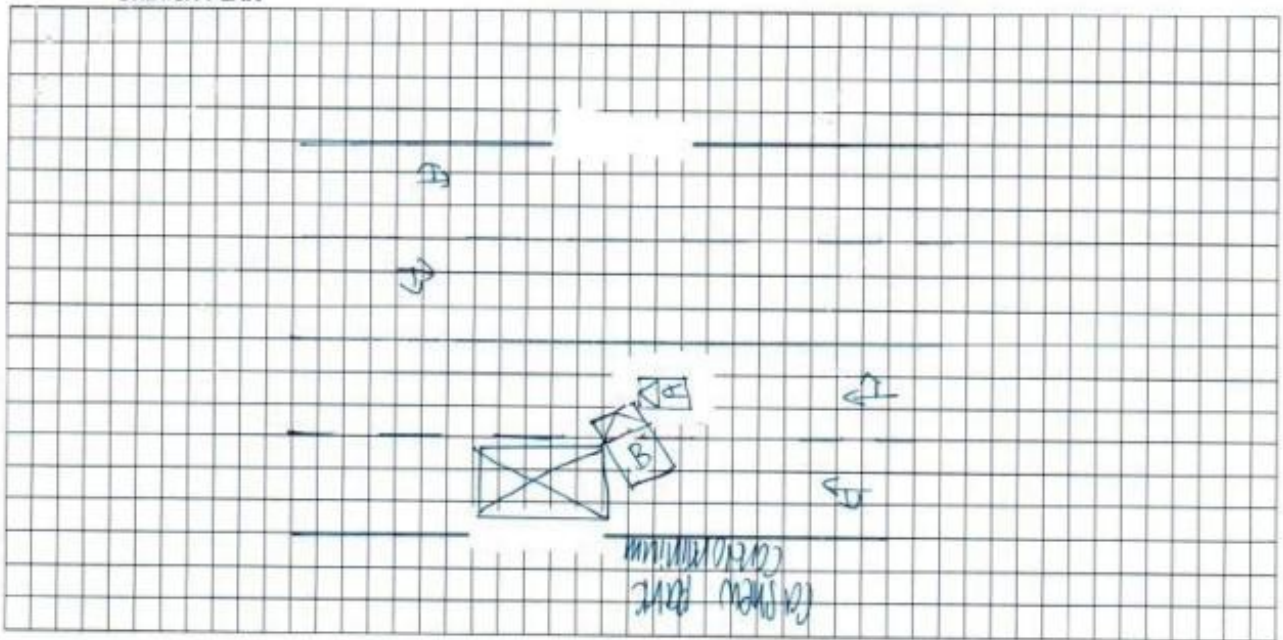

#### Brief Details.

On 13 April 2019, Saturday night at about 9.05pm, my friend, named XinHao, drop me a text informing that his got into an accident nearby Cashew Road. I asked if the rider was okay and needed any help. He mention rider is okay but motorcycle is damaged. I let XinHao know I'll go down to the mention location and see if I can help with the bike.

Upon reaching T-junction at petir Road, I saw Xinhao's friend motorcycle with a panda bag at pathment of the traffic light. His friend was no where to be found. When I was informing XinHao, I saw up ahead a guy wearing a helmet was walking back towards my direction, so I know that is the rider. I recognise the rider closer as he has been working food panda for quite sometime. I ask if he was okay and anywhere injured. He say he is fine but the driver didn't wanna stay behind, he keep on insisting he has work and have to go off. Immediately told him to stay with the bike while I rode my bike towards the driver.

Upon reaching, I took a quick glance on the vehicle plate number, in case he decides to go off and not acknowledge to this accident as I've faced the same situation before. Afraid that he would twist him words around, I followed for a short distance till he stop. Parking at least a 10-feet distance between his vehicle and mine, I took out my phone quickly took picture of the van, plate number GBH3975B and send to XinHao. I saw he wasn't coming down, so I got off my bike, approached the driver carefully looking out for on coming vehicles.

When I reach his window, I waved politely, to try get his attention as he was on the phone. He took a look at me, I signal to ask if he can wind down his driver side window. He immediately turn very aggressive and mad judging from his wide open looking eyes and hand gesture obviously asking what I want. Before I could even answer he proceed to move off again. I quickly hurry to my bike and followed his van. He drove very slowly, maybe about just 10km/h after noticing I was behind him again, then he slowed down even more. This time I over take to the right side of the lane, with him on the left side of the other lane, I signal to slow down and move one side. He went really slow this time so I thought he was gonna stop as there is a small road entrance in front that leads to the private estate. To ensure he stops, I Lane change to his lane, this time im in front of him but at a distance of maybe 100m apart, blocking his right of way right after the entrance so he can turn into the entrance of the private estate.

Instead of doing so, he overtake me and drove away really fast. I quickly followed and lane change to the right lane while he was on the left lane. I gave a huge wave and he fiercely stared at me while still being on the phone messaging. This time I shouted across to ensure he hears me, telling him I am going to call the police officers down if he still doesn't want to stop and settle this in a nice way. After finishing my sentence, he didn't slow down at all but this time he did a very quick u-turn towards my lane with me, riding my motorcycle just right beside him. His van and my motorcycle collided real fast and my motorcycle drop on the road losing my balance. After the collusion, the driver clearly meant to just drive away and not stop as he continue moving, dragging me along with my motorcycle facing front, to facing a 90 degrees towards the right side. As he drove of, I quickly

look up and saw he was too far away for me to stand up and chase. Being in pain, I heard a guy voice shouting really loud for the driver to stop and a girl came towards me to help. Security from cashew Park condo came to help too. I stood up, realising the car that was behind me, stopped with doors open. The lady that was assisting me pointed to that mention car and say they saw what happen and quickly got off. They manage to get the driver who hit me and whole situation got heated up as driver was shouting. We then call the police for assistance.
