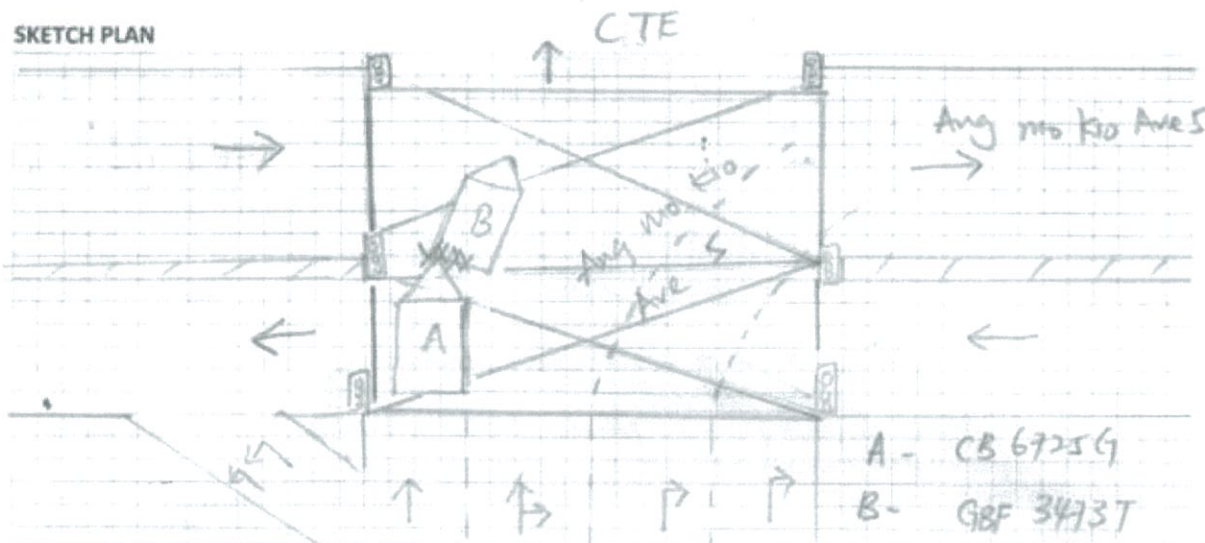

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 11/4/2019 @ 11:42 pm, my veh A CB 6725G was travelling out from Ang Mo Kio Ave 3, taking the slip road towards CTE passing by Ang Mo Kio Ave 5. I was all along travelling on the left most lane. At the junction with Ang Mo Kio 5, the 2 left most lanes are for going straight and 3 right most lanes are for turning right. I was still on the left most lane. As the traffic light turn green I simply proceed straight. Suddenly, the veh in front (veh B - GBF 3473T) flip on his right turning signal and do an emergency brake inside the yellow box with no other obstacles in front of him. I immediately brake also but did not manage to stop in time and our vehicle collided. No was injury involved.
