

**Brief Details.**

On the 04/04/2019 at around 1930hrs, I was riding my vehicle (FBH5863C) along Tampines Street 42 towards Tampines Avenue 7. I was approaching a yellow box that was nearby the carpark gantry along the road when I spotted a taxi (SHA7292C) on the opposite side of the road, about to turn right into said carpark gantry. I slowed down my vehicle in case he did not give me the right of way. The taxi then came to a stop inside corner of the yellow box. Upon seeing this, I sped up my vehicle to pass by him. All of a sudden, the taxi inched forward again into the yellow box and because of this I had to jam braked. My vehicle then swerved to the left.

The taxi driver got out of his vehicle to check what had happened. He had one passenger in the taxi with him. The both of us exchanged particulars. No parties in the taxi were injured.

Due to this incident, I suffered abrasions on my left palm, left wrist and left elbow as well as bruising on the left side of my ankle area and a stiff neck and lower back. I then visit Viva Medical Clinic who gave me 03 days of MC and a referral letter to the A&E of any hospital. My vehicle had damages on its left side fender as well as scratches on its left side. There was also oil leakage coming from my vehicle.
