

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I Masraff was assigned to CIE-REL-2 (XD 7447T) on 15.4.19. At around 1715hrs along Shelford Rd, I was reversing towards a dead end round-about. As I need to reverse till the end of road to do refuse collection, I drove with the side of my attendant. When I almost reversing to the end, I realised my position is incorrect and I move forward to adjust. And when I reversed again by steering my wheel towards the right, my truck front left side grazed on to the car's right front side causing damages. I immediately stop and exchange particulars and no one was injured.
