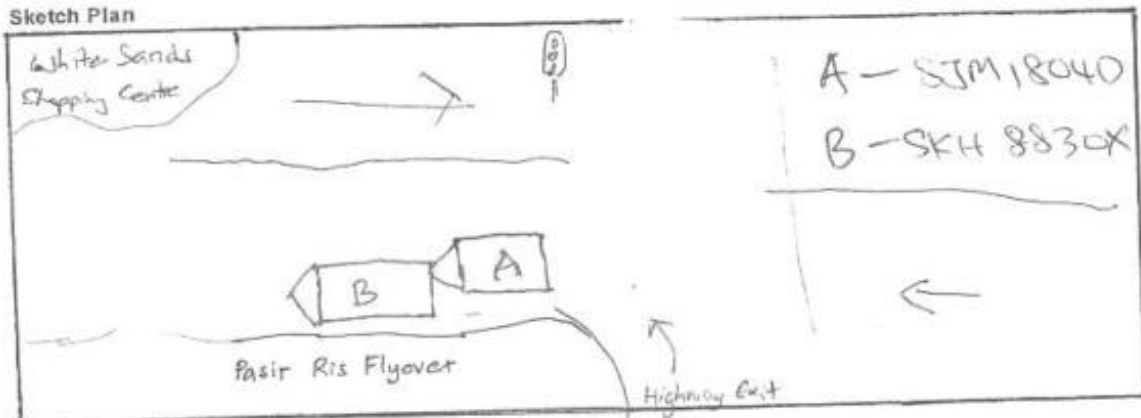

Sketch Plan




Common Statement

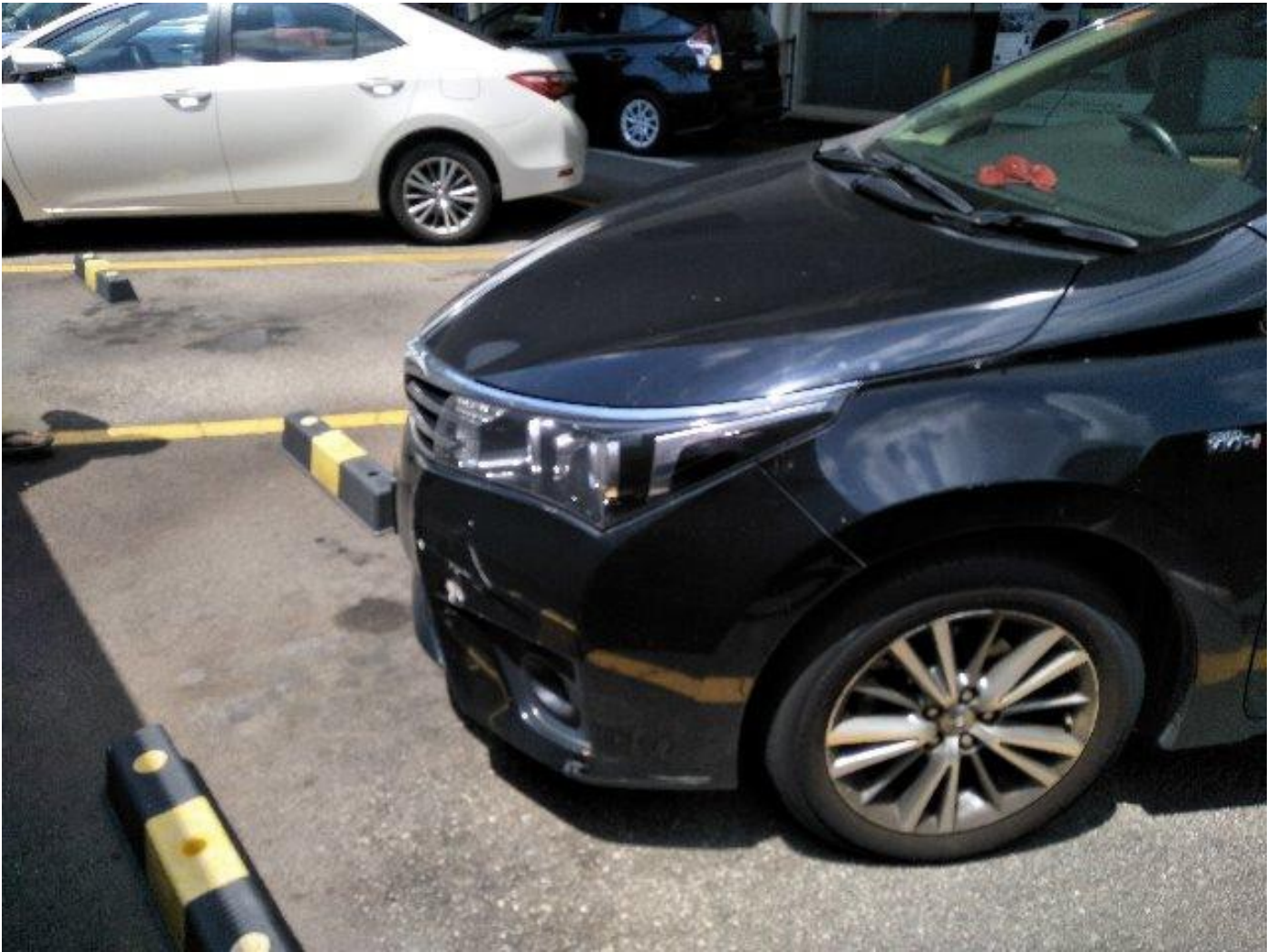

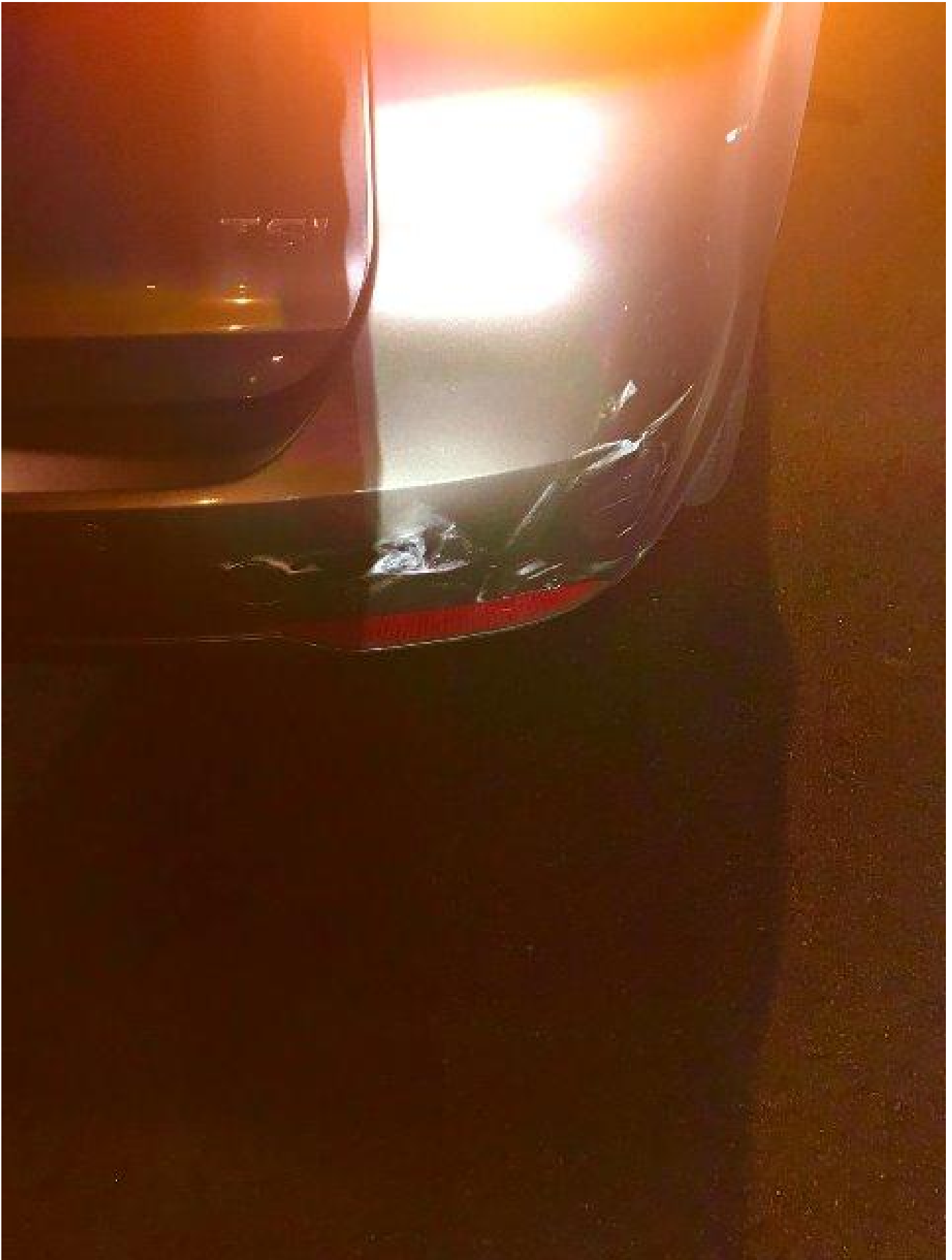
