Accident Sketch Plan



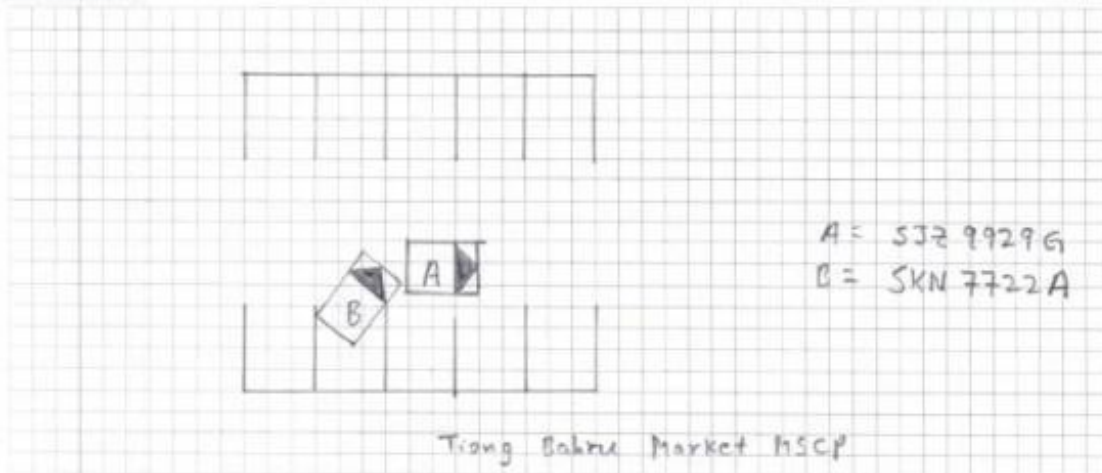
